## Rules and Regulations

**Booth Spaces:** Items can be displayed and contained within the 10'x10' space. A weighted tent is highly recommended for protection from the elements. All canopies must be weighed down with 40 lb. weights on each leg, tent weights must be in place immediately after erecting each tent. A vendor may not participate if they do not have adequate tent weights.

**Setup and Take Down:** Setup can begin as early as 9:00 a.m. and should be completed by 1 p.m. Take-down can start at 6:30 p.m. and should be completed by 7:30.

**Safety and Conduct:** Displays including tables are not to protrude beyond the allotted 10'x10' space to ensure traffic and safety throughout the festival. Vendors shall maintain an emergency and fire access and egress around the event and no structures may be placed within lanes. Any sandwich signs must not impede traffic flow. Any electrical cords shall be protected with cord-protectors to minimize hazards.

**Trash/Cleanup:** Sellers are responsible for their stall space and its surrounding perimeter. Before leaving, please be sure your area is clean and trash-free.

**Proof of Liability Insurance**

All vendors are required to carry product liability insurance and shall be required to provide to the market manager evidence of such coverage for the term of the 2022 Cowpoke Palooza dates. Uncompahgre Farms will be carrying general liability insurance for the event; however, in the event any action or inaction of a vendor or a vendor’s agent or employee, which results in a claim under the Uncompahgre Farms insurance, the vendor shall be required to pay the market’s deductible for any such claim in addition to any other legal remedy available to market. Minimum \$1,000,000 coverage with Uncompahgre Farms listed as additional insured.
